

3rd Round Document Verification Schedule for Technician - I for CEN 02/2024

1.0 A total of 05 candidates were shortlisted to appear for 2nd Round DV for Level 5 posts vide notice dated 25.06.2025 and the process of DV and Medical Examination of the candidates has been completed.

2.0 Further, candidate with the roll number given below is provisionally shortlisted for the 3rd Round Verification of Documents / Certificates & genuineness of candidature and Medical Examination down from the merit list in order to fill the shortfall in empanelment in Pay Level 5 due to absent, rejection, Unfit in Medical Standard etc. Candidates are advised to report to the office of Railway Recruitment Board, Guwahati, Panbazar, Station Road, Guwahati-781001, as per scheduled date and time mentioned below.

3.0 SMS / E-mail alerts are being sent to the candidates' registered mobile / email ID for downloading their e-call letter from the official website of RRB, Guwahati.

4.0 Candidates have to upload their signature, latest photograph and identification marks in the portal https://oirms-ir.gov.in/rrbdv/. The instruction for uploading is available in the portal. This portal will be active upto the date of DV. Candidates are advised to read the detailed instructions given in the DV e-call letter carefully.

5.0 The candidates called for DV should produce all the original documents along with two sets of photo-copies in A4 size as detailed in the CEN and e-call letter issued for Document Verification

6.0 Those candidates who will be called for Document Verification may note that after completion of DV, they will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of Northeast Frontier Railway (NFR) on the next day of the DV. The candidates are required to come prepared to stay for three to four days accordingly. Candidates have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals / Health Unit for the medical examination. In rare cases, where the investigations like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital / Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory / hospital.

7.0 The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency / deficiency / discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.

8.0 It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical examination does not entitle him/her in any way to an appointment in the Railways.

9.0 While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical / printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.

Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. If a candidate fails to produce the above mentioned original certificates on the date of document verification, his / her candidature is liable to be rejected and no further correspondence will be entertained in the matter. Further, please note that furnishing false information, deliberate suppression of information or using unfair means at any stage of exam will render the candidate disqualified and he/she will be debarred from appearing in any selection or appointment in Railway or to other Government services and if appointed, the service of such candidate is liable to be terminated in future.

4. It may be noted that merely calling a candidate for Document Verification & Medical Examination does not in any way entitle him / her to an appointment in Railways. Please note that the empanelment will be subject to correctness of all the information submitted by the candidate on-line application, CBT / Skill / Performance Test and verification of documents.
