5th Round Document Verification Schedule for Level 2 for CEN 01/2019 - NTPC Graduate & Under Graduate

1.0 A total of 302 candidates (251 in 1st Round, 35 candidates in 2nd Round, 11 candidates in 3rd Round and 5 candidates in 4th Round) were shortlisted to appear for DV for Level 2 posts vide notices dated 24.02.2023, 04.04.2023, 24.04.2023 and 16.05.2023 respectively and the process of Document Verification (DV) and Medical Examination (ME) of these candidates has been completed.

2.0 Further, candidates with the roll numbers arranged in ascending order (not in order of merit) given below are provisionally shortlisted for the 4th Round Verification of Documents / Certificates & genuineness of candidature and Medical Examination down from the merit list in order to fill the shortfall in empanelment in Pay Level 2 due to absent, rejection, Unfit in Medical Standard etc. Candidates are advised to report to the office of Railway Recruitment Board, Guwahati, Panbazar, Station Road, Guwahati-781001, as per scheduled date and time mentioned below.

3.0 SMS / E-mail alerts are being sent to the candidates' registered mobile / email ID for downloading their e-call letter from the official website of RRB, Guwahati.

4.0 Candidates have to upload their signature, latest photograph and identification marks in the portal https://oirms-ir.gov.in/rrbdv/. The instruction for uploading is available in the portal. This portal will be active from 23.05.2023 and upto the date of DV. Candidates are advised to read the detailed instructions given in the DV e-call letter carefully.

5.0 The candidates called for DV should produce all the original documents along with two sets of photo-copies in A4 size as detailed in the CEN and e-call letter issued for Document Verification.

6.0 Regarding the Document Verification process, candidates are advised to refer to the "NOTICE ON DOCUMENT VERIFICATION PROCESS" unloaded on the website of RRB, Guwahati on 14th September, 2022,

7.0 Those candidates who will be called for Document Verification may note that after completion of DV, they will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of Northeast Frontier Railway (NFR) on the next day of the DV. The candidates are required to come prepared to stay for three to four days accordingly. Candidates have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals / Health Unit for the medical examination. In rare cases, where the investigations like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital / Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory / hospital.

8.0 The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency deficiency / discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.

9.0 It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical examination does not entitle him/her in any way to an appointment in the Railways.

10.0 While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical / printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.

Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerized and the selection is based on merit of candidates only. Please visit the official websites of RRBs for regular updates and information.

1. Candidates must also bring the 02 sets of clear & legible self-attested photocopies each of the original certificates / documents along with e-call letter(i) Matriculation / High School Examination certificate or equivalent Certificate as proof of date of birth and Matriculation qualification. (the candidate's name and the father's /mother's name mentioned in the application will be verified with reference
to the names mentioned in this certificate). In case of variation in spelling in name, fathers name in the on-line application and original certificates / documents, candidates are required to submit relevant affidavit executed before Magistrate or
Notary on required stamp papers stating that the referred person in certificate(s) is one & same on the date of verification.

(ii) 10+2 / Inter / Higher Secondary / PUC / Equivalent Certificate (As applicable)

Notary on required stamp papers stating that the referred person in certificate(s) is one & same on the date of ventication.

must be noted that failure to report for the Document Verification on the scheduled date will tantamount to rejection of candidature unless it is supported by documentary evidence that the candidate had to appear in a niversity / Government examination or due to sickness of the candidate. No other reason for absence will be considered. No fresh e-call letter will be issued.
