Document Verification (5th Round) Schedule for Level 3 for CEN 01/2019 - NTPC Graduate & Under Graduate

1.0 A total of 87 candidates (59 in 1st Round ,18 candidates in 2nd Round, 07 candidates in 3rd Round & 03 candidates in 4th Round) were shortlisted to appear for DV for Level 3 posts vide notices dated 24.01.2023, 17.02.2023, 16.03.2023 and 21.04.2023 respectively and the process of Document Verififcation (DV) and Medical Examination (ME) of these candidates has been completed. Further, candidate with the roll number given below is provisionally shortlisted for Verification of Documents / Certificates & genuineness of candidature and Medical Examination in order to fill the shortfall in empanelment in Pay Level 3 due to Absent, Rejection, Unfit in Medical Standard etc. Candidate is advised to report to the office of Railway Recruitment Board, Guwahati, Panbazar, Station Road, Guwahati-781001, as per scheduled date and time mentioned below.

2.0 SMS | F-mail alents are being sent to the candidates' registered mobile / email ID for downloading their e-call letter from the official website of RRB, Guwahati.

3.0 Candidate has to upload his signature, latest photograph and identification marks in the portal https://oirms-ir.gov.in/rrbdv/. The instruction for uploading is available in the portal. This portal will be active from 09.06.2023 and upto the date of DV. Candidate is advised to read the detailed instructions given in the DV e-call letter carefully.

4.0 The candidate called for DV should produce all the original documents along with two sets of botoc-copies in A size as detailed in the CEN and e-call letter issued for Document Verification.

5.0 Regarding the Document Verification process, candidate is advised to refer to the "NOTICE ON DOCUMENT VERIFICATION PROCESS" uploaded on the website of RRB, Guwahati of the control of the process of the control of the process of the proce

ded on the website of RRB. Guwahati on 14th September, 2022.

6.0 The candidate called for Document Verification may note that after completion of DV, will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of RRB, Guwahati on the next day of the DV. The candidate is required to come prepared to stay for three to four days accordingly. Candidate have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals / Health Unit for the medical examination. In rare cases, where the investigations like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital / Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory / hospital.

7.0 The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency / deficiency / discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.

8.0 It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical examination does not entitle him/her in any way to an appointment in the Railways.

9.0 While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical / printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.

Candidates must also bring the 02 sets of clear & legible self-attested photocopies each of the original certificates / documents along with e-call letter(i) Matriculation / High School Examination certificate or equivalent Certificate as proof of date of birth and Matriculation qualification. (the candidate's name and the father's /mother's name mentioned in the application will be verified with reference to the names mentioned in this certificate). In case of variation in spelling in name, fathers name in the on-line application and original certificates / documents, candidates are required to submit relevant affidavit executed before Magistrate or Notary on required stamp papers stating that the referred person in certificate (as applicable)
(ii) 1042 / Inter / Higher Secondary / PUC / Equivalent Certificate (as applicable)
(iii) A University degree or its equivalent.
(iv) Other certificate / diploma as prescribed under minimum educational qualification in Annexure of detailed CEN 01/2019
(v) The Educational Qualification Certificates viz. Provisional or Regular should contain the date of issue. The date, time & place of Medical Examination will be intimated at the time of DV. Please note that you should be prepared to stay for more than 4 days for DV / Medical examination at your own cost.
