IMPORTANT NOTICE

SECOND & FINAL OPPORTUNITY TO APPEAL FOR RE-MEDICAL EXAMINATION FOR THE UNFIT CANDIDATES AGAINST CEN 01/2018

After Document Verification (DV) for the post of ALP & Technicians under CEN No. 01/2018, candidates were sent for Medical Examination to the nominated Railway Hospitals by this office. Based on the Medical Fitness assessed by the nominated Railway Hospital Authorities and Medical Board, total **92 candidates** have been found UNFIT in the prescribed medical category for the post applied by them. Intimation Letter was sent to all these **92 candidates** who had been declared Unfit by the Medical Board through Registered posts, so that they can appeal, if they so desire, to **Pr. Chief Medical Director, N. F. Railway.** Accordingly, some appeals have been received. However, in case any candidate did not receive our letter, then he/she is hereby given this second & final opportunity to prefer such an appeal within 20.01.2020.

Candidates, who want to prefer appeal, may attend this office (Railway Recruitment Board, Station Road, Panbazar, Guwahati- 781001) and submit appeal addressed to <u>Pr. Chief Medical</u> <u>Director, N. F. Railway routed through Chairman, Railway Recruitment Board, Guwahati</u> on any working day, on or before 1700 hours of 20.01.2020 with relevant documents. Candidates who submitted appeal earlier in response to this office letters need not appeal again.

Please note that if the candidate fails to appeal within the stipulated period, no additional time will be given.

It is also clarified that even if a candidate was found Unfit in a particular Medical Category but fit in other category/categories then he/she has already been considered, while forming panel, considered for the posts for which he is fit. Also, please note that appeals are usually considered only in exceptional case of error in the Medical Examination and Report.

PROCEDURE OF APPEAL:-

Such an appeal shall be entertained, only if,

- (i) Appeal with justification duly signed by the candidate indicating his/her Roll No., Registration No. & Date of Document Verification.
- (ii) The candidate should produce a certificate in the attached prescribed format (Annexure II) from a Government/Private Doctor of the Specialty/specialties in which the candidate has been found Unfit.
- (iii) Such certificate should contain a note that the Government/Private Specialist is fully aware of the physical and visual standards sent by the Railways for the particular medical category, and that he is aware of the fact that you have already been declared unfit according to these standards during medical examination conducted by an appropriate Medical Board comprising of three Senior Railway Doctors appointed by the Government in this regard.

- (iv) The certificate should bear the photograph and mark of identification of the candidate duly attested by such a Government/Private issuing Authority. Such an issuing authority shall also clearly mention his/her full name, designation, address etc. and its MCI/State Registration Number.
- (v) Moreover, in terms of Railway Board's letter No. 2014/H/5/8 (policy) dated 31.12.2015, candidates declared unfit upon medical examination submitting appeal to PCMD are required to pay Rs. 1,000/- through DD payable in favour of **PFA, N. F. Railway, Maligaon**. In case the appeal is considered and decision changes from Unfit to Fit, the DD submitted to Railway will be refunded to the candidates. In all other cases, the DD will be credited to Railway in same head where medical examination fee is deposited.
