# CEN 01/2019 (NTPC) - NOTICE FOR MEDICAL APPEAL (PAY LEVEL - 6 & 5)

After Document Verification (DV) for the posts of NTPC Levels 6 & 5 under CEN No. 01/2019, conducted from 10<sup>th</sup>, 11<sup>th</sup>, 12<sup>th</sup>, 13<sup>th</sup>, 17<sup>th</sup> October, 2022 and 21<sup>st</sup> November, 2022 for Level 6 and from 12<sup>th</sup>, 13<sup>th</sup>, 14<sup>th</sup>, 15<sup>th</sup>, 16<sup>th</sup>, 19<sup>th</sup> December, 2022, 31<sup>st</sup> January, 2023 and 16<sup>th</sup> February, 2023 for Level 5, candidates were sent for Medical Examination to the nominated Railway Hospitals by this office.

Based on the Medical Fitness assessed by the nominated Railway Hospital Authorities and Medical Board, the following **7 candidates** for levels 5 & 6 have been found UNFIT in the prescribed medical categories for the posts applied by them, as a result of which they have not been empanelled:

Candidates, who want to prefer appeal against the decision of the medical committee concerned may submit an appeal for medical re-examination addressed to the <u>Pr. Chief</u> <u>Medical Director</u>, N. F. Railway, <u>Maligaon</u>, <u>Guwahati</u> - 781011 routed through <u>Chairman</u>, <u>Railway Recruitment Board</u>, <u>Guwahati</u> on or before 1700 hours of 07.04.2023 with relevant documents by speed post or delivered by hand.

Please note that if the candidate fails to appeal within the stipulated period, no additional time will be given.

It is also clarified that even though a candidate was found Unfit in a particular Medical Category but fit in other category/categories, possibility of empanelment of these candidates in categories for which they have fitness as per their merit and choice has been examined while forming the panels. Also, please note that appeals are usually considered only in exceptional case of error in the Medical Examination and Report.

### PROCEDURE OF APPEAL:-

Such an appeal shall be entertained, only if,

- (i) Appeal with justification duly signed by the candidate indicating his/her Roll No., Registration No. & Date of Document Verification.
- (ii) The candidate should produce a certificate in the attached prescribed format (Annexure II) from a Government/Private Doctor of the Specialty/specialties in which the candidate has been found Unfit.
- (iii) Such certificate should contain a note that the Government/Private Specialist is fully aware of the physical and visual standards sent by the Railways for the particular medical category, and that he is aware of the fact that you have already been declared unfit according to these standards during medical examination conducted by an appropriate Medical Board comprising of three Senior Railway Doctors appointed by the Government in this regard.
- (iv) The certificate should bear the photograph and mark of identification of the candidate duly attested by such a Government/Private issuing Authority. Such an issuing authority shall also clearly mention his/her full name, designation, address etc. and its MCI/State Registration Number.
- (v) Moreover, in terms of Railway Board's letter No. 2014/H/5/8 (policy) dated 31.12.2015, candidates declared unfit upon medical examination submitting appeal to PCMD are required to pay Rs. 1,000/- through DD payable in favour of **PFA, N. F. Railway, Maligaon**. In case the appeal is considered and decision changes from Unfit to Fit, the DD submitted to Railway will be refunded to the candidates. In all other cases, the DD will be credited to Railway in same head where medical examination fee is deposited.
