Provisional Result of Written Examination of Various Categories

On the basis of their performance in the Written Examination held on dates mentioned below, the following candidates have been provisionally found eligible to be called for Document Verification (D.V.). It may be noted that this result is provisional and subject to fulfilling of all eligibility conditions laid down in the Centralized Employment Notice mentioned against each. Roll Numbers are arranged in ascending order (last six digits) and not in the order of merit. The RRB has the right to rectify /alter any inadvertent error in the list of roll numbers. At the time of document verification, candidates should produce all original certificates in proof of date of birth, academic qualification, caste (where applicable) and other relevant testimonials. Call letters are being dispatched by Registered Post to the candidates individually for appearing in the D.V. to be conducted on dates mentioned against each in the office of RRB, Guwahati. This RRB is not responsible for any postal delay or wrong delivery. However, if any candidate does not receive the call letter, he/she may report to RRB on 25.02.2013 along with counter foil of the call letter of Written Examination. All the candidates may be required to stay for 1 or 2 more days and they must come prepared for the same. In case of any unforeseen reason, the DV is required to be postponed/ cancelled, no travelling /daily allowance will be paid. **No request for postponement of the Date / Reporting Time mentioned below will be entertained under any circumstance and no further chance will be given.**

All OBC, SC and ST candidates called against OBC, SC and ST quota vacancies, who do not feature in the General (UR) list, should note that their candidature is provisional and they will be considered for provisional empanelment only after OBC, SC and ST candidates who are in the General (UR) 30 % extra list and having higher merit position than OBC, SC and ST quota candidates, have been considered first for empanelment against OBC, SC and ST quota vacancies. Thereafter, OBC, SC and ST quota and their 30% extra candidates will be considered. Therefore, all candidates provisionally called for DV against OBC, SC and ST quota vacancies may or may not be provisionally empanelled finally.
